Practitioners are able to change the benefit record number from 0 when adding a new employment instance Workforce Administration > Job Information > Add Employment Instance

A fix was made in release 4.10 that prevents practitioners or the system from changing the Benefit Record Number to values other than zero.

An exception to this was found when adding a new employment instance. This release updates the behavior of Add Employment Instance to match that of Job Data to prevent
