Require “Comments” for Admin Approvals</p>	<ul style="list-style-type: none"> • Admins will see a comment field the right beach compliance transaction • Top Admins can enter a comment to indicate the reason they are approving the data instead of the designated Approver • The transaction cannot be saved until there has been entered in the comment field.
<p><u>TL Approval Compliance</u> 3. New Admin Approval Error message.</p>	<ul style="list-style-type: none"> • If an Admin does not enter a comment in the Admin Approval they will receive the following ERROR message: • “Comments are required for all rows Approved by an Admin”.
